This includes identifying opportunities for growth and innovation, providing technical assistance and training to entrepreneurs and businesses, and fostering partnerships among stakeholders.
- Key Responsibilities:
- Identify opportunities for entrepreneurship and value chain development in target industries and sectors.

- Develop and implement programs that support entrepreneurship and strengthen value chains, including business incubation, mentorship, and access to finance.
- Provide technical assistance and training to entrepreneurs and businesses on topics such as business planning, marketing, financial management, and product development.
- Foster partnerships among stakeholders, including businesses, government agencies, NGOs, and academic institutions, to support entrepreneurship and strengthen value chains.
- Conduct research and analysis on market trends, consumer behavior, and industry dynamics to inform program development and decision-making.
- Design Livelihoods Input support to beneficiaries on Climate resilience programming
- Formed communities to manage CBOs for market collection point
- Community Mobilization and capacity development for stakeholders (host and camps)
- Provide Capacity development training for high value product/ high value vegetables production techniques, value chain dev for individuals
